RE: Criminal Conspiracy to Impersonate Peace Officer Case #IRM451842 and Civil Restraining Order Case #30-2013-00666827-CU-HR-HNB Felony Filing of a False Document Deprivation of Honest Government Services

Dear Presiding Judge Saunders,

Although I have experience a long and persistent problem with the Orange County Superior Court traffic division, including serious violations of law, mail statutes and the requirement of government personnel to provide the intangible right to honest government services, I am writing to you today regarding the two above referenced cases that the Superior Court of Orange County handled involving the Director of Public safety of the City of Irvine, David Maggard.

The City of Irvine operates as a Council Manager form of government, and is a Charter City. I have confirmed the City Charter does not contain the term "Chief of Police" and in no way abrogates the elected City Council from appointing a Chief of Police for the City.

I have also confirmed that the City of Irvine has not filed any paperwork with any city, county or state government for the purposes of operating as an alternative form of government. The Irvine City Manager has no authority to abrogate the obligation of the elected Irvine City Council to appoint a Chief of Police.

During the proceedings of traffic Case # IRM451842, exculpatory evidence was submitted to the court that the Irvine City Council did not appoint a Chief of Police named David Maggard and that the City of Irvine has no authority to exercise its power. This evidence was removed from the court record, and replaced with the term 'nunc pro tunc,' evidence which is exculpatory in nature and by the courts actions denies me the intangible right to honest government services in a conspiracy to defraud and impersonate a California Peace Officer while attempting to defraud for '\$' using the USPS.

The Orange County Superior Court then proceeded to convict me, using the identity of a state issued, and state maintained birth record in a conspiracy to deny me constitutionally secured rights and profit from the use of a title of nobility against my will and without any legitimate consent.

During the civil proceedings of Eib v Maggard Case # 30-2013-00666827-CU-HR-HNB, the issue of me being harassed by City of Irvine employees following me in a gang stalking conspiracy, intrusively and without a warrant searching my unoccupied automobile, openly

authority of the Irvine 'Chief of Police' David Maggard was brought to the attention of Judge Mathew Anderson.

Judge Anderson was also made aware of the felony committed by David Maggard when he publicly filed an Oath of Office with the words "Chief of Police" clearly written on it, Judge Anderson responded that he had "real felonies to deal with." Apparently Judge Anderson primarily handles criminal cases, cases that are likely to come from the City of Irvine while Judge Anderson has personal knowledge that the Irvine City Council has not appointed a Chief of Police. The civil restraining order proceedings were conducted in a courtroom reserved for criminal matters and I was obliged to sit at a desk labeled 'defendant' while 2 Sheriff deputies were standing in an intimidating manner over me in violation of personal space during the proceeding. When I referenced the California Judicial Council's Judges Handbook on Restraining Orders, Judge Anderson screamed at the top of his lungs "I don't care what the Judges Handbook Says."

Although Mr. Maggard did not claim to be a Chief of Police during the civil restraining order trial, he did claim he was 'technically' a chief of police because he was appointed to the office of Director of Public Safety by the City Manager, Allison Hart. Judge Anderson, in his decision on this matter made a point to refer to Mr. Maggard as "Chief of Police" even though he was aware Mr. Maggard was not appointed Chief of Police by proper authority, and Mr. Maggard had filed a false document at the Irvine City Clerk's office, the Orange County Recorder's office and the California Secretary of State office which clearly states "Oath of Office.... Chief of Police."

Judge Anderson willfully and intentionally ignored a felony committed by Maggard, and openly and willfully participated in the ongoing impersonation of a California Peace officer.

My intention of sending you this letter is to serve several purposes, primarily to deny the Orange County Superior Court and certain court employees and judicial officials from claiming plausible deniability as to its involvement in conspiring to impersonate a peace officer, conspiring to deny me honest government services, conspiring to commit mail fraud, conspiring to profit from the use of a State issued birth record as a title of nobility, and other serious crimes.

I demand you, or your designee respond to the reference made by Judge Anderson in court of dealing with 'real felonies' while on the bench, please explain which felonies listed in the California Penal Code are not real, and which felonies are, by Judge Anderson's words, fake felonies with no legal legitimacy.

I look forward to your prompt response. Acknowledgement of receipt is respectfully demanded.
