## **Summary of Finding (continued)**

Mr. Eib did not provide a valid California Driver License during the hearing. Based on his statements, it was evident he was stopped by Officer Bemiller while driving on northbound I-405 at Mulholland Drive. A check of Mr. Eib's license status confirmed he was suspended. During the hearing, Mr. Eib did not provide any information or evidence to indicate an error was made on behalf of the CHP. After reviewing all information, it was determined Officer Bemiller was in compliance with law and CHP policy in impounding Mr. Eib's vehicle for 22651(p) VC.
