16 **Declaration**

17  
18 I, Corey Eib, do declare as follows;

19  
20 That I aver my domicile is within the boundaries as stated in the  
21 1849 Constitution of the State of California. I am a citizen of one  
22 of the several states as the term 'citizen' is used in Article 4,  
23 Section 2, Clause 1 of the Constitution of the United States of  
24 America. I am one of the People of California as the term is used in  
25 the Preamble of the 1849 Constitution of the State of California.  
26 My permanent place of abode is geographically within the posted city  
27 limits of Los Angeles, California. I do not consent to my legal

1 presence in the United States,<sup>1</sup> nor am I aware of any legal authority  
2 which authorizes my presence in the United States.

3  
4 On November 25<sup>th</sup> 2016 after being stopped and detained by Mr. Bemiller  
5 of the CHP, and upon his demand for me to produce a CA DMV Driver  
6 License, I produced acceptable identification<sup>2</sup> which rebuts the  
7 presumption of residency in this state.<sup>3</sup> A copy of my identification  
8 was received by this court on April 5<sup>th</sup> 2016 and entered into the  
9 record of these proceedings.

10  
11 On November 25<sup>th</sup> 2016, I did not possess or present to the arresting  
12 officer, a form of government issued identification in the specific  
13 name sequence of FIRST/MIDDLE/LAST.

14  
15 On November 25<sup>th</sup> 2016, while under arrest, Mr. Bemiller, questioned me  
16 if the address he used on the complaint in this case is a valid  
17 mailing address. I positively and clearly responded with the correct  
18 and true statement that the mailing address used by Mr. Bemiller on

1 the complaint he filed into the record of this case is not a valid  
2 mailing address. Further, I attempted to dissuade Mr. Bemiller from  
3 using this address on the CA Judicial Council form as it was and is  
4 not a valid address where the court can mail correspondence related  
5 to this case.

6  
7 On November 25<sup>th</sup> 2016 while detained by Mr. Bemiller, and after having  
8 produced acceptable identification, an officer, without consent,  
9 grabbed my USA passport booklet from its visible location on the  
10 front seat of my automobile. The passport booklet was taken to Mr.  
11 Bemiller's CHP cruiser and used for unknown purposes by Mr. Bemiller  
12 without my permission; I do not consent to the use of a passport for  
13 the purpose of establishing residency in this state.

14  
15 On November 25<sup>th</sup> 2016 I was not employed by this state, any other  
16 state of the United States, or the United States while traveling by  
17 automobile within the boundaries as stated in the 1849 Constitution  
18 of California.

19  
20 On November 25<sup>th</sup> 2016 I was not a resident of this state, any other  
21 state of the United States, or a resident of the United States.
